Whereas Mary-Ann Baldwin has lost the trust of Citizens by abolishing support for Raleigh's Citizens Advisory Councils first established in the early 1970's by Raleigh's first and only Black Mayor, Clarence Lightner,

Whereas Mary-Ann Baldwin has demonstrated serious conflict of interest by accepting employment with a contractor immediately after awarding the contractor a multi-million dollar contract with the City of Raleigh,

Whereas Mary-Ann Baldwin seeks to provide multimillion dollar tax breaks to private developers to the detriment of Raleigh's taxpayers,

We, the undersigned, hereby petition for the recall of Mary-Ann Baldwin and demand an election for successor of Mayor in accordance with Article IV, Section 4.2 of the Raleigh City Charter.
